- 2. Victoria Baker Coaching reserves the right to refuse entry/hire without stating the reason, and deny all rights of admission.
- 3. Victoria Baker Coaching does not accept any responsibility or liability for any injury, accident, damage or illness to any person, property or animal whatsoever, or for any loss whatsoever, arising out of, or occurring from any hire/coaching and each entrant shall indemnify the organisers against any legal action whatsoever arising from any accident.
- 4. Everyone must take all reasonable precautions to avoid and prevent accidents occurring.
- 5. Any individual seen to be causing distress or suffering to any animal will be asked to leave and may be reported to the appropriate authorities.
- 6. No horse or pony under the age of 4 years shall be ridden in coaching sessions unless specifically geared to the age and ability.
- 7. BRITISH STANDARD APPROVED HARD HATS MUST BE WORN AT ALL TIMES WHEN MOUNTED. Full and correct PPE attire must be worn by all competitors when hiring the Cross country no yard boots.
- 08. It is the owners/riders responsibility to ensure that horses/ponies are the correct fitness and condition for the activity you are doing.
- 09. Horses and/or ponies must not be left unattended at any time when tied outside Horseboxes or trailers.
- 10. No horse and/or pony may be lunged in any area, unless permission is granted.
- 11. Participants are requested, prior to leaving, to clean up any droppings or hay, straw or shavings around their horsebox/trailer and to dispose of these at home.
- 12. Cancellation of any lessons within 24hours of the booking will be charged for in full.
- 13. All areas must be left clean and tidy following any hire. If not left clean & tidy an invoice will be sent.
- 14. Advise Victoria Baker Coaching in advance if bringing a Stallion. Stallion Discs & Ribbons MUST BE WORN
- 15. VBC reserve the right to charge an admin fee of £5 per entry when refunding.
- PLEASE MAKE SURE THAT YOUR VEHICLES ARE LOCKED AT ALL TIMES.
